# **Powai Family Booked for** ₹ 18 Cr Fraud

of the city police has registered a case against a couple and their daughter for allegedly duping a financial institution of ₹18.5 crore. The trio allegedly used forged bills and invoices to avail a loan between November 2015 and May 2016.

According to the complaint filed by a senior relationship manager in the corporate finance department of Hero

FinCorp, the directors of Leeway Logistics, Sanjay Kumar Sinha, his wife Namita Sinha, and daughter, took loans allegedly for buying forklifts.

"However, when they defaulted on the repayment and the EMIs, the complainant found that several bills and invoices submitted by the accused were forged,

after all records were revisited as a part of an internal enquiry," a police officer said.

The fraud was confirmed when the companies whose bills were submitted denied selling any such product or equipment. A senior police officer said the accused's residence and office in Powai were found locked. "We are trying to locate them and will also try to ensure they do not flee the country," said an EOW officer.
